1.Approval of June B&C Meeting Minutes

a. Board vote: Liz motioned to approve minutes as written and not as formatted. Lori 2nd. Liz voted to approve: 13 approved, 4 abstentions.

1. SDCRID Updates:

a. Board Vote: Jen motioned to appoint Andrea Slaughter to PDC co-chair. Kevin seconded. Discussion regarding the committee and necessity of maintain 2 chairs. Jen motioned to close discussion. Kevin 2nd. Vote: Nathan abstain, motion passes.

b. Discussion regarding the SDCRID Upstander award. Historically, this awards ceremony, previously called Member of the Year, was a significant amount of work and financial cost.

2. RID Update

a. Jen updated the Board about RID Leadership Changes:

Erica West Odeyele who was the Region V Representative, will take over as Vice President. Erica's new position leaves the Region V Representative position vacant. If there is any interest from local membership, please contact Jen.

b. Vacant Positions

RID has announced it is beginning its search for Executive Director and applications will remain open until September 1, 2016. Anna Witter-Merithew is serving as interim executive director. RID is also looking to hire for the Senior Director of Programs and Services position.

c. CASLI

The Center for the Assessment of Sign Language Interpretation has hired a new Director of Testing, Michele Martinez-Saeva.

d. Jen will submit her annual report to RID about SDCRID's goings on.

3. RID will host its National Conference July 2017 in Salt Lake City, Utah. Discussion regarding limited space capacity to 650 participants. RID will allow 650 registrants: 450 on the LEAD track and 200 on the ASL Immersion and Interpreting Skills Development Track. Priority will be given to affiliate chapter leadership. Concerns about excluding Deaf/HOH as well as other members.
