For our logo contest 2020 we are looking for original art depicting “what SDCRID means to you” that can be used as our new logo. The contest is open to all SDCRID members in good standing and residents of San Diego County with a connection to the San Diego Deaf Community. Artists of all ages may enter (see Release of Minors form if under 18.)

All entries must be submitted no later than December 31, 2020. Voting will be open until January 22, 2021. Entries are subject to an initial screening process, then qualified entries will be sent out to SDCRID members for vote. The winning logo will be determined by majority vote and announced by January 31, 2021. **The winner will receive \$200.00!** The winning logo may be featured on our website, promotional material and wear, at our meetings and events, on posters and flyers, or other materials representing SDCRID.

- Submit your own original artwork only, per these specifications:
 - Format Options: PNG, PDF, or JPEG
 - Minimum size 3’ x 3’
 - On white or transparent background
 - 4 Color limit
 - Emailed submissions have a maximum file size of 25 MB
- Plagiarized artwork will automatically be disqualified.
- All submitting artists grant SDCRID the right and permission to use their name, photo/ likeness in local and social media as part of the contest
- If chosen, the winning logo will be delivered to SDCRID as a high quality (300 ppi) vector graphic on transparent background
